FOR THERAPIST USE: Note pigments, blades, techniques to be used for this client

Please read the following statements carefully: Microblading is a way of cosmetic tattooing. Re-touch procedures may be required. A minimum healing period of 4 weeks is required before a touch-up procedure can be performed. On a rare occasion, the pigment may migrate under the skin. The procedure of microblading may be slightly uncomfortable. Immediately after the procedure, the pigment can appear 30-50% darker than the desired result. Please note that pigments will fade. Although extremely rare, there might be an immediate or delayed allergic reaction after the full procedure. Allergic reactions to anesthetic can also occur. Permanent cosmetics cannot be applied to any person under the age of 18, pregnant women or nursing mothers (you can do microblading when you are breast feeding but you need to have milk stored for 5 days after the procedure). Infections can occur if the aftercare instructions are not followed correctly and possible scarring may occur but is extremely rare. There may be swelling and redness following the procedure and you may experience minor bleeding. It should also be noted that if you have an MRI screen within 3 months after a microblading procedure, you should notify/discuss this with your doctor. I have received aftercare instructions and I am fully aware of the aftercare procedures. I have fully understood the information provided above and can confirm that all of the information provided by me, is correct and truthful.
